Executive summary

Woodford Primary School is an inclusive, non-selective, non-denominational one form entry primary school and nursery in the pre-opening phase with a preferred opening date of September 2022. The school will be part of the Laurus Trust, a multi-academy trust that operates Cheadle Hulme High School, Gorsey Bank Primary School, Cheadle Hulme Primary School and four other schools in the area. This report details the formal Section 10 consultation.

Woodford Primary School (“Woodford”) will provide outstanding teaching and an environment where every child will be encouraged to ‘Dream Big’ so they can ‘Fly High’. Pupils will be valued and nurtured allowing them to flourish and succeed.

Stockport Local Authority and the Department for Education selected the Laurus Trust to be the school’s sponsor on 17th December 2021. The formal statutory consultation ran from 17th January 2022 to 6th March 2022.

The local community has responded very positively throughout this period however, we recognise the concerns raised about the school potentially not being big enough to meet demand. We would like to thank all those who have taken the time to give feedback. Suggestions and comments have been considered, responded to in this document and where appropriate incorporated into the proposals for the running of the school.



The proposer group

The Laurus Trust is a multi-academy trust with Cheadle Hulme High School (“CHHS”), the founder school, and Gorsey Bank Primary School at its centre. CHHS is a hugely oversubscribed academy converter and has been judged Outstanding in every category by Ofsted in 2011 and 2015.

In 2018 we opened three new free schools all of which are oversubscribed: Cheadle Hulme Primary School, Laurus Cheadle Hulme and Laurus Ryecroft. In 2019 we opened our fourth free school, Didsbury High School.

Hazel Grove High School joined the Trust in September 2019 shortly after it had been judged Requires Improvement. In January 2022, the school was judged a “Good” school by Ofsted and was Outstanding in 3 out of 5 categories. Inspectors commented *“Leaders and staff collaborate very well to set highly ambitious goals for pupils and students. Pupils and students enjoy the wide range of subjects that they study. They receive the high-quality encouragement and support that they need to achieve increasingly well.”*

We were delighted to have been selected by Stockport MBC to operate the new primary school for Woodford.

Our vision

For everyone regardless of background or circumstance to be inspired, to thrive in all environments, to recognise what it takes to succeed, to set aspirational goals and work hard to achieve them.

The vision is shared across all schools in the Laurus Trust and is reflected in every aspect of school life.

Statutory consultation

The statutory section 10 consultation commenced on 17th January 2022 and ran for 7 weeks to 6th March 2022.

Information provided to stakeholders took the following forms:

1. Public consultation booklet (please see Appendix 1). This booklet was made available in digital and printed form and detailed the Proposer Group, key individuals, the vision, ethos and proposal for the new school and key information on the consultation process. It also provided information on how stakeholders could give feedback as well as come to face to face meetings to have their questions answered

and share their views.

2. Laurus Trust and Woodford Primary School websites carried information about the proposed school, the consultation process, a downloadable consultation booklet as well as an online questionnaire to complete.
3. A leaflet drop to 3,500 local residents took place on 28th and 29th January 2022 highlighting the consultation and the drop-in events.
4. An advert was placed in the Stockport edition of the Manchester Weekly News and the Stockport Express highlighting the consultation drop-in events. These papers have an audience of over 75,000 readers.
5. Consultation meetings – two events were held both at Woodford War Memorial Community Centre, within walking distance of the school site. One was in the morning and one was early evening. The Executive Head Primary, Head of School Designate and Trust senior leaders hosted the events. Large boards provided information about the Trust, our existing schools and our proposed vision, curriculum and admission arrangements for Woodford.
6. Regular Facebook and Twitter updates throughout the 7 week period reminded stakeholders of the consultation.
7. Tours at Cheadle Hulme Primary School were offered to prospective parents as a means for them to gain more information.

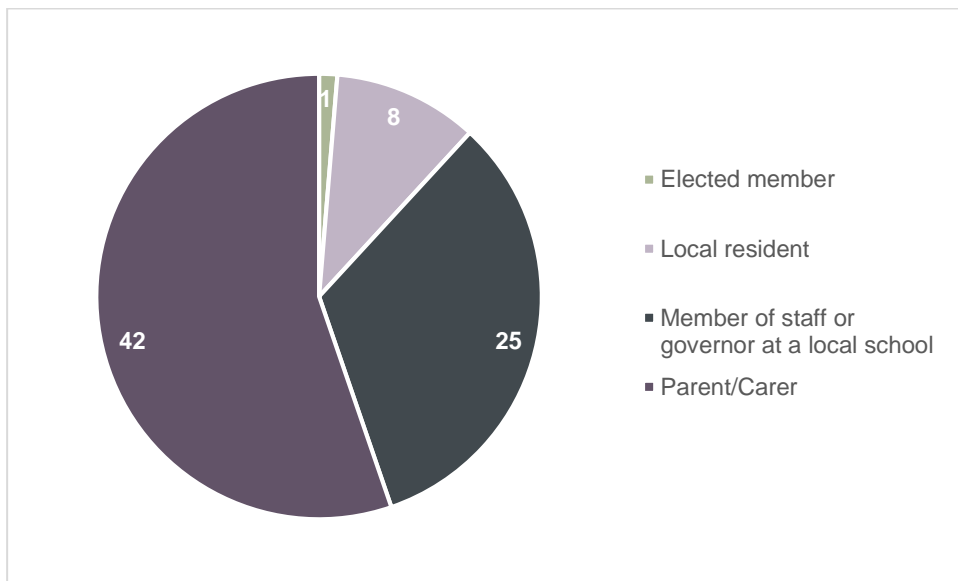

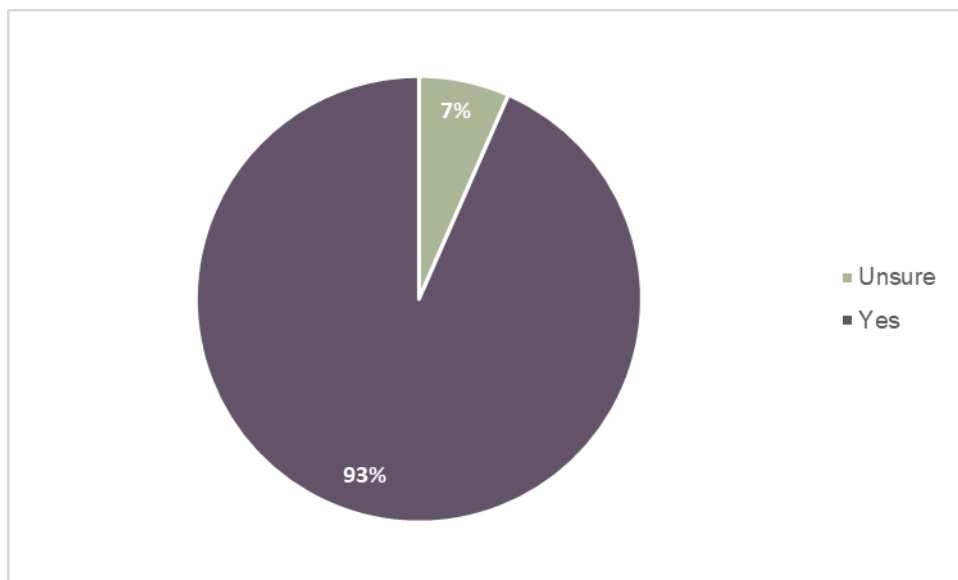
Statutory consultation results and responses

76 consultation questionnaire responses were received. Replies to the 6 questions asked were as follows:

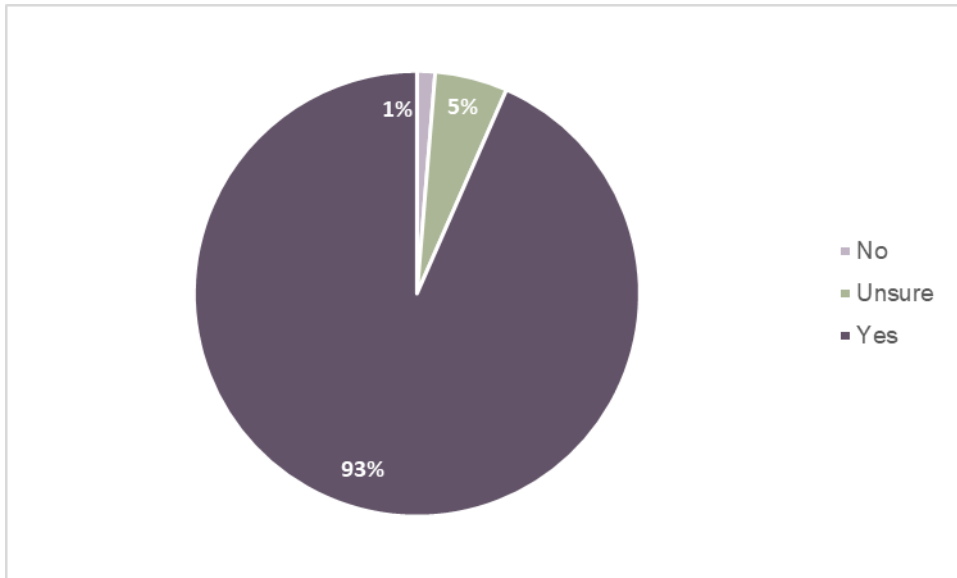
1. What best describes you?



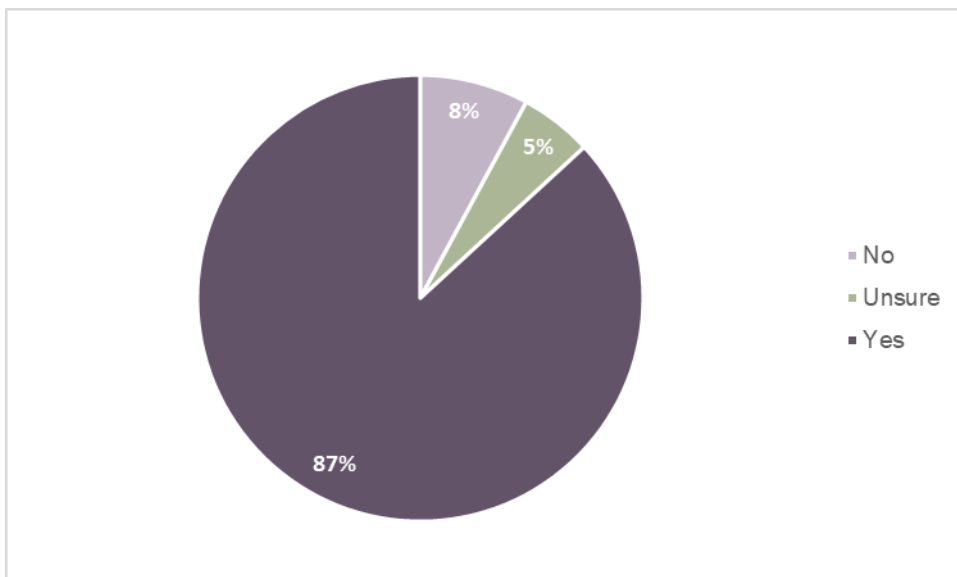
2. Do you agree that opening the proposed Woodford Primary School will meet a need to provide additional school places in Stockport?



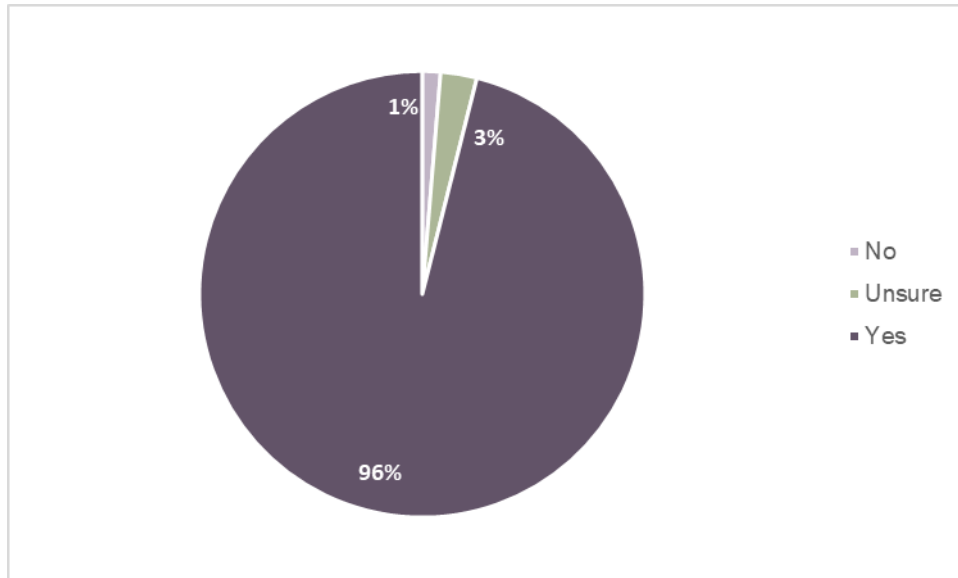
3. Do you agree that the vision and curriculum plan of Woodford Primary School meets the needs of the community?



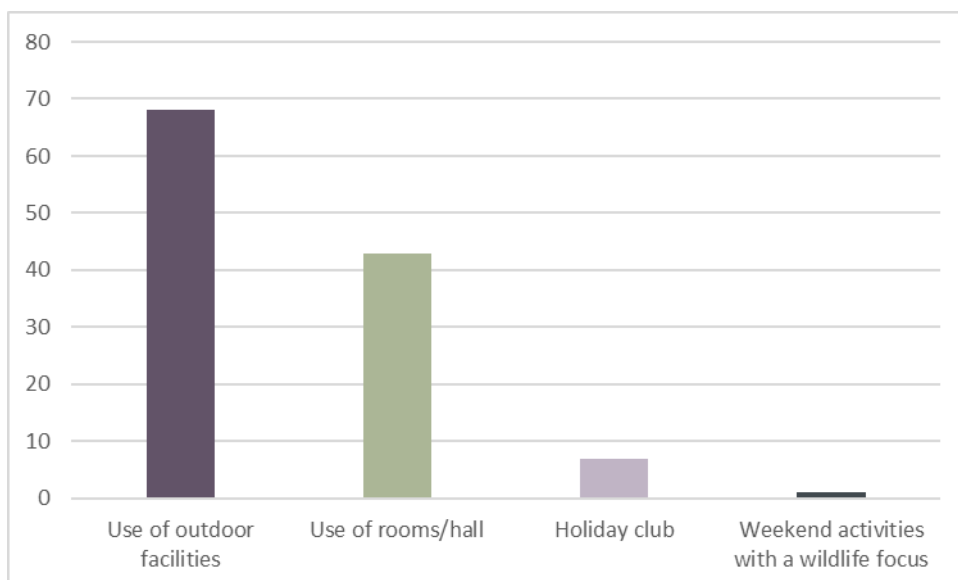
4. Do you support the Admissions arrangements we are proposing for Woodford Primary School?

Our response:

We were pleased with the number of responses we had to the consultation questionnaire and that, for each question posed, there was a significant majority in favour. Of the 76 respondents, 61 responded 'yes' to every question.

Only one respondent – a member of staff or governor at a local school – answered 'no' to the Laurus Trust setting up the free school. The question asking if respondents were supportive of the proposed admissions arrangements gave the highest number of unsure and negative responses – 10 in total. Most of these respondents, and indeed many at the drop in events, were concerned that a one-form entry school was not big enough to cater for all the families on the Woodford Garden Village estate. We addressed the admissions in detail at the consultation events and have provided FAQs on our website. We explained that the decision to open a school with 30 places per year group was taken by the Local Authority who are responsible for providing school places for Stockport residents and that demographic information suggested only a one-form entry school was required currently. We also explained that the Department for Education stipulates that free schools only open one year group at a time and unfortunately, children already in other local schools could not be transferred to this school.

We are committed to ensuring the community will benefit from our facilities and will look to offering a holiday club once the school has reached an optimum size.

All respondents had the opportunity to provide further comments to their answers.

"I've heard nothing but good things about the Laurus Trust; from parents and employees, and we're excited to hopefully be part of the family."

"As a parent survey completed throughout the estate has already highlighted that the school will be immediately oversubscribed, it's important that there is a fair way of deciding on which children are given a place at the school. As a mother of a child with an EHCP in progress, it's helpful to know that this may help his application as we really want to attend the school; but whatever the outcome it seems as though the admissions will be taken care of fairly. The policies outlined seem efficient and fair all round."

Our response: The Laurus Trust's vision to address the demand for places and enable every pupil to flourish and succeed is central to our proposal. It is helpful to know that local parents/carers and residents appreciate that the proposed Woodford Primary School will meet local need.

Negative comments

Of the 76 respondents, 1 responded 'no' to three out of four questions and provided the following comments:

"Queensgate Primary School - a local school - was in a very good position to provide the vision and curriculum that is already well established in the area. Local primary schools with established nurseries will be negatively impact as parents choose 'shiny and new' over established excellence. This will equally be the case for parents of Reception children."

"The school should have no impact on other local primary schools - but will. It is understood that the school's footprint is designed to become a 2 form entry in time. This will negatively impact on the excellent schools in the local area."

Issue: The school will negatively affect other local schools by becoming two-form entry in the

future

Our response: The Laurus Trust will not expand the school to two-form entry without the agreement of Stockport MBC.

“Lots of people moving to Woodford garden village are moving because of the local schools and how the catchment area is full of outstanding rated schools. I’d be worried that this school won’t be outstanding rated and also that there will be teething problems because it’s a new school and that kids will suffer as a result.”

Issue: The school is unproven and there will be teething problems.

Our response: The Laurus Trust has successfully opened four other free schools that are all oversubscribed. Woodford will undergo a pre-opening Ofsted inspection in June and will undergo a full Ofsted inspection within its first three years. Additionally, the Head of School Designate is a highly experienced Early Years professional who has prior experience of opening a new school.

Other comments

“While I love everything about the proposed school I am concerned about the uniform. In my opinion, requiring young children to wear blazers, shirts and ties is not practical or comfortable for them. On a recent visit to Cheadle Hulme Primary School, we were told that many children do not wear the blazer for most of the day. It therefore does seem a little pointless to require one in the first place. Perhaps as they move into the older year groups it would be more appropriate but I disagree that 4 year olds should wear this uniform. I feel like a simple polo shirt and jumper would be more appropriate.”

Issue: The uniform should not include a blazer.

Our response: Blazers replace coats for much of the year. Pupils take pride in wearing them and it adds to their sense of belonging. We will recommend more than one uniform supplier and limit the number of branded items on the uniform list to ensure affordability and value for money for our parents.

“Having compared the admission arrangements to other schools, the first two criteria do not seem standard and concern me if they attract others from outside the area as a priority as it may take places from the estate children. I am also interested in the purpose of these admission criteria given they are not standard.”

Issue: The oversubscription criteria in the admission arrangements is not standard



Our response: The admissions policy is compliant with the Schools Admissions Code. All oversubscription criteria is taken directly from the template and has been approved by the Department for Education. Looked after children is a mandatory first criterion.

“Due to the volume of new families moving onto the estate I think a 2 form entry is needed.”

“It is unfortunate that only the Nursery and Reception years will be opening initially as this does not fulfil the requirements of local residents. I appreciate that it would be difficult to open up the whole school initially, but for example if at least up to Year 2 was open from 2022 this would enable more local children to attend the school, and help with those who have a sibling currently at another school with another due to start Reception this year.”

“I believe you should be opening more classes initially, there are clearly enough children on the estate to support a whole KS1 at least, the Stockport MBC data is incorrect and outdated.”

Issue: the school should be two-form entry and open in September 2022 for older year groups, not just reception and pre-school

Our response: The Laurus Trust has been appointed to operate a one-form entry free school by Stockport MBC. The Local Authority is required to provide enough school places for all Stockport residents, and currently the LA data indicates that a one-form entry school is sufficient. The Laurus Trust would support the expansion of the school when more primary school places in the local area are required. New free schools can only open with an entry Reception year group in order not to disrupt the other local schools in the area.

Conclusion and next steps

There has been extensive ongoing consultation with a wide range of stakeholders. Feedback has been undeniably supportive and positive. We have listened and adapted our proposals to address issues raised during this process for example we are considering the viability of a holiday club provision at the school.

The most commonly raised issue is concern the school is not big enough for the local community and we will raise this with both the Local Authority and the Department for Education.

We are confident our school will provide additional much needed places for parents/carers in the Woodford community. This has been the most common response received from those in support of the school. The Trust will now begin the process of agreeing a Funding Agreement for Woodford Primary School with the Secretary of State for Education.

We would like to thank all stakeholders who have taken the time to read and hear about our plans and provide feedback. We will continue to work with all stakeholders to consider further feedback about the development of the school and to address concerns raised.

Who are the Laurus Trust?

The Laurus Trust is a Multi Academy Trust founded by Cheadle Hulme High School (CHHS), an 11-18 secondary school, and Gorsey Bank Primary School (GBPS), a high-performing primary school in Wilmslow in 2016. We have since opened four further free schools in 2018 and Hazel Grove High School joined the Trust in September 2019.

All of our schools are heavily oversubscribed and have a reputation, both locally and further afield, for outstanding teaching and learning. We have also been approved to open an 80-place Alternative Provision School in Stockport, Laurus Grace, which will cater for students with significant social, emotional and mental health needs.

The Laurus Trust Vision is, 'for everyone, regardless of background or circumstance, to be inspired, to thrive in all environments, to recognise what it takes to succeed, to set aspirational goals and work hard to achieve them.'

Our proposal

We are proposing to open Woodford Primary in September 2022, initially by providing 30 Reception places. A further Reception class would be added each academic year until Woodford Primary grows to a thriving 210 pupil, one form entry school in September 2028. The school will also be home to a 20 place Nursery for 3 and 4 year olds.

Located at the heart of the Woodford Garden Village community, our intention is for Woodford Primary to be a local school for local children. It will be an inclusive, non-selective, non-

denominational one form entry school where all pupils can thrive, regardless of their background or circumstance.

We are proposing that the Secretary of State for Education enters into a Funding Agreement with the Laurus Trust. A Funding Agreement is the contract between the Secretary of State for Education and the academy that sets out the terms on which the academy is funded. This will enable the school to open to its first cohort of pupils in September 2022.

Why does Woodford need a new primary school?

Under section 6A of the Education and Inspections Act 2006 (the 'free school presumption') where a Local Authority identifies the need to establish a new school it must, in the first instance, seek proposals to establish an academy. Stockport Council has identified the need to establish a new Primary School in Woodford to open in September 2022.

Woodford Garden Village is a new housing development and when completed will comprise 920 residential dwellings. It was agreed as part of planning obligations that the developer would build a one form entry primary school upon occupancy of the 450th house. The developer has committed

to delivering a school building in June 2022.

Health visiting data suggests that there are sufficient children to sustain a one form entry primary school emerging from the development.



What can you expect from Woodford Primary School?

At Woodford Primary School pupils will feel safe and secure, valued and cared for. School will be an enjoyable, exciting place where every pupil will flourish and succeed.

We believe that the most effective way to achieve self-worth for every child is by being unashamedly academic, unapologetically aspirational and by having uncompromising standards within a culture of:

- *Valuing hard work – we do whatever it takes for as long as it takes*
- *Continuous improvement*
- *Respect and trust*
- *High expectations and ambition*
